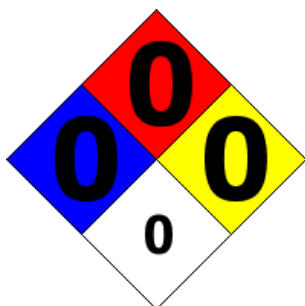

Description of first aid measures

Precautions for safe handling:
